



# 2020 Daily Crime and Fire Log

The Daily Crime and Fire Log includes a record of all crimes reported to campus safety that occurred anywhere within the department's patrol jurisdiction and all fires reportedly occurring in the residence halls over the past 60 days. The log is designed to provide timelier details and greater information to the campus community than the annual statistical disclosures.

The most recent 60 days of the log is available on the campus safety web page but the log is also available for public inspection upon request during regular business hours at the campus safety business office. Older portions of the log are available within two business days of request at the same location. If a log entry disposition changes after 60 days have passed the log may not reflect those changes.

In general, entries in this log will be given one of the following dispositions to reflect the current status of the incident:

<b>Term</b>	<b>Definition</b>
<b>Active</b>	There is an active investigation regarding this incident.
<b>Cleared (no follow-up necessary)</b>	This incident has been resolved with no further action necessary.
<b>Cleared by Arrest</b>	This incident has been resolved by arrest.
<b>Cleared by Exception</b>	This incident was resolved — no arrest made.
<b>Referred to LASD</b>	This incident was referred to the Los Angeles County Sheriff's Department for follow-up.
<b>Referred to Student Life</b>	This incident was referred to Deans office for follow-up.
<b>Inactive</b>	This is currently no further action to be taken regarding this incident.
<b>Unfounded</b>	Law enforcement has determined that no offense occurred nor was attempted.
