TMU Graduation Requirements

Maintain a minimum GPA of 2.00 (cummulative) in all TMU Courses. Some majors have different GPA requirements.

Complete a minimum of 32 semester units at TMU, not including Directed Studies coursework.

A maximum of 12 units can be transferred to complete degree requirements after the last 12 units taken at TMU.
